2.	Resubmission of corrected XML files and Forms by Record Officers/Commanding Officers/Authorities <ul style="list-style-type: none"> - Final orders by EROs. 	By 15.09.2020 (Tuesday)
3.	Final publication of the last parts of the electoral rolls.	On 25.09.2020 (Friday)

2. SSR, 2020 may be undertaken and completed as per the above schedule, in accordance with provisions contained Manual on Electoral Rolls, 2016 and instructions issued vide Commission's letters No. 24/2019-ERS (Vol-IV), dated 05th February, 2020 and 12th March, 2020.
