DIVISION OF MAHARASHTRA LEGISLATIVE COUNCILNotice under rule 31(3) of the Registration of Electors Rules, 1960

- In pursuance of rule 31(3) of the Registration of Electors Rules, 1960 each of the Electoral Registration Officers whose particulars appear in the FIRST SCHEDULE below hereby calls upon every person entitled to be registered in the electoral roll of the constituency mentioned in the said Schedule to send to or deliver at his Office, on or before 7th November, 2022 at the latest, an application in Form 19 appended to the Registration of Electors Rules, 1960 and reproduced in the Second Schedule (Form 19) below, for inclusion of his/her name.
- The applications may also be sent to the Assistant Electoral Registration Officers / Designated Officers whose particulars are shown in the FIRST SCHEDULE. As the electoral rolls for the Teachers' Constituencies are required to be prepared afresh every time before an election, all persons whose names are included in the existing electoral rolls for these Constituencies should also submit fresh applications in the prescribed form.
- Qualifications:- Every person who is a citizen of India, and is ordinarily resident in the Konkan Division Teachers' constituency and has, within the six years immediately before 1st November, 2022 been engaged for a total period of at least three years in teaching in any of the educational institutions, within the State specified to be not lower in standard than that of a Secondary School is eligible to be included in the electoral roll. The list of Educational Institutions so specified is available with the officers mentioned in the First Schedule.
- Every application in Form 19 by person seeking enrolment in Teachers' Constituency shall be accompanied by a certificate from the Head of the Educational Institution certifying the engagement of the person concerned as a teacher for a total period of three years within the last preceding six years. The format for the certificate will be as follows:-

ISO Quality Jobs: ISO 9001 standards provide the leading quality management system (QMS) to manufacturing / service enterprises for their continuous business improvement and increased customer satisfaction. They provide independent approval from a third party about quality standards of products / services. ISO has several other types besides the standard of 9001. These include ISO 14000 on environmental issues, ISO 27000 regarding data security and privacy, ISO 22000 reg food security and control, among others. All these audit companies offer substantial job opportunities for quality professionals as auditor or lead auditor. However, all these jobs need some amount of work experience.

BIS Officer: Bureau of Indian Standards (BIS) is the national standards body set up by the government of India to ensure quality of goods. For some industries for public health safety, the BIS certifications have been made mandatory. There is

thus a good opportunity at BIS for students who would like to make quality assurance as a career.

Six Sigma Consultants: Six sigma is a set of specialized tools used to minimize defects and improve quality of goods. Six sigma experts undertake various problem-solving tools to achieve this. There are several levels of certifications, most preferred being lean six sigma "yellow belt" and "black belt". These professionals are in a high demand zone as quality experts both within the company as well as external consultants.

Educational Qualifications:

A basic graduation degree in any discipline can be the starting point for a quality profession. However, most recruiters prefer a master's degree. An MBA degree with "operation / manufacturing specialization" is possibly the most preferred qualification. Special certifications like ISO or six sigma are preferred for a successful quality profession. Certification in "Agile" is the other preferred certification as combination of six sigma and agile is essential for a perfect quality strategist.

Needed Competencies:

Strong practical application, problem solving, analytical skills, customer focus are the most needed competencies for a successful career in quality domain. Communication ability, both oral as well as written, is preferred. Many jobs in the quality domain need work experience and hence internship during degrees is desirable.

Conclusions:


As India endeavors to become a global manufacturing hub, focus on quality will continue. Job opportunities in quality will, therefore, be substantial in future for the right type of students.

Corporator Bharati Patil demands closing of sewage drain in Koparkhairane

A menace to the society

Begging is one of the most serious social issues in India. It is unfortunate that despite our country making rapid economic growth, a large section of the society still reels under poverty. Growth of any city is synonymous to its industrialization and economic development. The huge manpower needed for sustaining this development process actuates the rural urban shift leading to migration from nearby rural areas. Most of the time the city is not able to provide the basic amenities required for living to this migrating population, who then seek shelter in the slums. These squatter settlements or slums are in fact the by-product of uncontrolled urbanization. The slum population keeps multiplying at a very high rate and more mouths to feed than hands to earn, leading family members especially the children, either into crime or begging. These are two fields, which do not require any sort of investments and are a source of easy money.

The moment you stop your car at the traffic red light, scores of beggars come running and ask for alms. Whether it is a dirty looking woman with a child in her arm or a little boy with a runny nose banging the car window or a handicapped old man asking for coins- the scenario is the same whether at railway stations, tourist spots, temples etc. If someone refuses to pay, they dare to abuse and even try to inflict damage on the vehicles in their bid to show displeasure. If a person happens to be travelling in an auto rickshaw, they create embarrassing scenes by touching feet, begging with folded hands, displaying empty stomachs and sometimes by even crying, in turn forcing the person to yield and give alms. At times, out of sheer pity, we tend to give them some coins or money and shoo them away.

Apart from this, these beggars along with the vendors pose a grave accident threat as they continue with their business without caring for the traffic and the onus for their safety lies with the vehicle driver.

Begging in India has become a big racket. For many, begging is just like any other profession. They go out to earn money, not by working, but by begging. In fact, there are begging gangs, who have their own gang leaders. Each leader allots a particular territory for a group of beggars and the day's earnings are shared among them. These beggars are so involved in begging that they don't want to work elsewhere.

The government, various organizations, activists claim that many measures have been taken to abolish begging and it has been successful to a certain extent. But the trend of begging still continues. While the government is doing its bit, we too can help in curbing this menace to some extent. The best way to do so is to stop giving alms. Instead of giving coins, one may give them food instead, if the beggars claim to be hungry. But efforts should be made to persuade them to slog for earning their livelihood rather than resorting to easy money making through begging. The physically handicapped beggars should be taken care of. Beggars who are willing to work should be trained according to their ability, health and talent. The ban on begging will help curb the trend of forcing children into this trade. The government should provide necessary vocational training to rehabilitate them. If begging is not checked immediately, it will turn out to be a big social evil in the near future.

• Construction of Forest Tourism Center at Thitbi, Naneghat in Murbad taluka and Sonale in Padgha forest area of Bhiwandi taluka under Forest Tourism Development Programme.

• Installation of nets in dangerous areas in Malshej Ghat area to prevent landslide accidents and for the safety of tourists.

• Under the tourism development program Malshej Ghat, Gorakhgad in Murbad taluka, Palu, Singapur and Sidhagad which is the burial place of Martyr Bhai Kotwal in Thane district to provide basic facilities for tourists.

• Construction of large-scale forest ponds and forest dams in Bhiwandi, Shahapur and Murbad taluka to ensure abundant and perennial availability of drinking water for wildlife.

• Efforts to make villages tanker free by supplying water to villages through cement concrete dams.

• To implement the tool bank concept for the upliftment of farmers through women's self-help groups.

• Promotion of self-employment by providing battery operated moped bikes to disabled persons.

• Efforts were made for the upliftment of farmers through various schemes related to agri-

culture and efforts were made to raise the standard of living of farmers by implementing various activities like vegetable cultivation program under human development programme.

While strengthening the medical facilities during the Corona period, modular operation theaters were set up in various government and municipal hospitals in the district and modular labor rooms and modern laundries were set up in some hospitals.

• A modern agriculture project is being implemented on approximately more than 60 acres of land in the abandoned alms house at Kalyan in Jambhul taluka and the first agro

tourism center is being developed there through the district administration.

• Sports Excellence Center in Thane city provided world class weightlifting sports equipment for daily practice.

Similarly during the Covid-19 affected period, he was instrumental in arranging 80 railway trains and 5700 ST buses for migrant laborers and citizens from Thane to their native villages. He also arranged distribution of 2 lakh food items every day under a community kitchen.

He distributed around 20,000 bags of essential food supplies to the needy in Thane district and arranged transportation from Mumbai Airport to Thane for 13,834 passengers arriving in Thane district through 1419 flights from 53 countries under 'Vande Bharat Mission'. As most of the flights arrive at the airport at night, care was taken to ensure that the work would continue round the clock.

E-passes were arranged for passengers to travel from Thane to

this year. In the year 2021, there were 8 patients of dengue and 44 patients of malaria. This year, till September, 68 patients have been diagnosed with malaria and 10 patients with dengue, said Chief Medical Officer Dr. Pramod Patil.

As part of its activities to destroy the breeding sites, the Navi Mumbai Municipal Corporation has visited 7782 places to find mosquito breeding sites. Dengue mosquito breeding has been found at 297 places in the city. 6483 houses have been sprayed with medicine and 7332 houses have been fumigated.

Double decker to run in Navi Mumbai now

If all goes as per plan, Navi Mumbai will soon have double decker buses like Mumbai. As per the official from the Navi Mumbai Municipal Transport wing, ten new electric double decker buses will soon be added to the fleet. An agreement has been reached regarding this and its tender process has been implemented.

For the past several years, Navi Mumbai Municipal Corporation (NMMT) has been running at a loss. Therefore, various initiatives are being undertaken to make the transport department more profitable.

NMMT has started using CNG and electric vehicles over diesel to avoid environmental pollution and cut on losses. Accordingly, 180 buses have been taken in the fleet of Navi Mum-



bai Transport under the FAME 1 and FAME 2 schemes of the Central Government. Now 75 more buses will be taken. Among them, 15 electric buses and two electric double decker buses for tourists will be introduced in the next 3 months. So in total, ten electric double decker buses will be introduced in eight months.

The Transport Department has a total of 567 buses. Of these, 430-450 buses ply on the road every day. It has 197 buses on diesel. 180 electric buses and 109 CNG buses are ply-

ing on the roads. Overall 51% eco-friendly and 49% diesel buses are running. Therefore, in the future, increasing this percentage, more and more eco-friendly buses will be seen on the road. "Navi Mumbai Transport Department has emphasized on purchasing eco-friendly electric buses to avoid pollution. In the next few days, 15 electric buses and double decker buses will be inducted into the transport fleet and a tender process has been conducted for it", said Yogesh Kaduskar, Manager, NMMT.

Dumper driver loses control on Vashi bridge

Three injured as the dumper collides with 9 to 10 vehicles

On Sunday evening near the toll booth on Vashi bridge, the driver of the dumper, who was coming to Navi Mumbai from Mumbai, lost control and hit nine vehicles. All the nine vehicles were extensively damaged and three people were injured. After this accident, the dumper driver escaped and the Vashi police detained the cleaner along with the dumper. It is said that due to the failure of the steering of the dumper, the driver lost control over the dumper.

Dumper No. MH-46-AF-6694 involved in this accident was coming to Navi Mumbai carrying debris from Mumbai on Sunday evening.

The driver lost control of the dumper after it came near the toll booth. So the dumper went ahead hitting all the vehicles in front of it. After that, this dumper hit a two-wheeler on the side of

the road and stopped. The dumper driver then fled. In this accident, two persons on the bike were trapped. Both of them were evacuated by traffic police and fire brigade personnel. But both of them sustained serious injuries on their legs.

Similarly, one person in the car sustained minor injuries. All the injured in this accident have been admitted to the hospital for treatment.

In this accident, 9 to 10 vehicles such as ST bus, WagonR car, Mercedes car, tempo, Tavera, I-20, Baleno and a two-wheeler and other vehicles were damaged in this accident.

The Vashi police have seized the dumper that caused the accident and started searching for the dumper driver who escaped. Due to this accident, there was a traffic jam on the Vashi bridge on the lane going towards Pune.

Keeping the school bags light

Whether to stop giving homework altogether or to continue the age old practise of giving homework, if yes then how much? has been an ongoing debate among parents and school management. The issue has once again caught the attention after the state education minister said that the state is contemplating doing away with the homework for students in schools.

Homework has been a part of the Indian teaching method. Whether the method has yielded the needful result is not known as there are no actual records to prove it unlike in the western countries. Earlier, during the 80 and early 90s, homework was mainly given in subjects which required much practice such as maths and science that too from higher classes i.e. 6th standard onwards. However, of late there has been a trend where children in 1st standards are given homework as well.

Schools and education stakeholders need to actually change

the rules and make the process of learning fun based rather than simply putting extra pressure on just completing homework and notes of school. On an average a child spends minimum 2 hours every day doing homework apart from that there is mounting pressure of preparing for weekly and monthly exams and tests. Eventually, the child is left with no extra time for hobbies or any other extracurricular activities.

While homeworks help students prepare for tests, but too much homework overwhelms students. Excessive amounts of homework prevent students from learning anything because they are just trying to get it done quickly.

Most schools assume all students work relatively fast on homework and class assignments, but that's not the case for every student. Every student learns at a different pace. With changing times, the method of teaching needs to change.

Tide pooling ecotourism planned at 8 places along Maha Coast

Mangrove Foundation explores livelihood options for local communities



With a view to promote eco-tourism in Maharashtra coast, the State Mangrove Foundation has picked eight destinations to introduce tide-pooling - an outdoor activity along the shoreline during low tide to view this previously hidden biodiversity and ecosystem at such rocky intertidal zones.

"We are assessing the feasibility of introducing this activity across these eight locations by involving the local community, and further plans are being developed for this based on the study," Virendra Tiwari, Mangrove Foundation Executive Director, Mangrove Foundation, said.

Eight locations along coastal Maharashtra - three in Sindhudurg district namely Tambeldega, Kunkeshwar and Bhogwe while five locations in Ratnagiri district including Katghar, Hedvi, Kharviwada, Velas and Vengeshwar - have the potential for coastal tide pool tourism as a livelihood options for the local communities.

The intertidal zone of rocky coasts is home to some amazing formations, including intertidal rock pools (also known as tide pools), which serve as microhabitats for numerous coastal creatures.

The rocky coast has the highest density of macroorganisms compared to other intertidal shores, as well as the greatest diversity of animal and plant species. Numerous marine creatures use the tide pools as refuge, food sources, and nursery grounds, the Mangrove Foundation said.

"This is a great initiative to promote education and knowledge about coastal biodiversity," said B.N. Kumar, director of NatConnect Foundation. "These kinds of projects should help in creating awareness to protect our coasts at a time when an increasing number of projects are being allowed under the guise of infrastructure and development," Kumar said.

The Mangrove and Marine Biodiversity Conservation Foundation of Maharashtra funded the study by the Sálim Ali Centre for Ornithol-

ogy and Natural History (SACON) under its Small Grants Programme. The study - Documentation of fauna from Tide pool ecosystems along the Ratnagiri and Sindhudurg Coast, Maharashtra - led by Goldin Quadros, Shirish Manchi and Siddhesh Bhave found a wide range of sea creatures with 303 coastal species overall across these rocky tide pools.

This included 30 seaweed and algae species, 80 phytoplankton species, 73 zooplankton species, 90 species of megafauna, both vertebrates (mammals, birds, reptiles and fishes) and invertebrates (crustaceans, echinoderms, annelids, amphipods among others), as well as 30 bird species, across the two coastal Konkan districts covering 288 km.

The goal is to systematically catalogue the rocky tide pools, he said and explained that researchers surveyed 45 rocky coastal areas and selected 25 locations with a continuous 500-metre long rocky coastline for this study, Tiwari said.

More rocky intertidal areas were documented in Ratnagiri than in the Sindhudurg district. The survey was done during three seasons - pre-monsoon, monsoon, and post-monsoon. All the rocky tide pools in Sindhudurg district had good species diversity, with maximum species recorded at Kunkeshwar and minimum at Girye Ghari pools, the study found. In Ratnagiri district, maximum species diversity was recorded at Velas (also famous for the Turtle festival) and minimum observed at Gaokhadi rocky tide pools.

"The ecosystems in rocky tide pools are significant because they support a wide range of biodiversity. These pools can soon provide food security, in addition to serving as nursery for a range of species. The coastal youth can have a means of subsistence if they have a grasp of ecosystem diversity, functions, and values," said Goldin Quadros, Principal Scientist at SACON and author of the study.

Congress committee demands removal of dumping stop from sector-30 in Kharghar

Acting on the complaints from the residents, the Kharghar Congress Committee has written to the Panvel City Municipal Corporation (PCMC) to remove the dumping stop for waste collected in Kharghar and take it directly to Taloja MIDC dumping yard. The residents around sector-30 area of Kharghar have been complaining about the massive accumulation of garbage at the dumping stop which is causing several health issues.

Speaking to Newsband, Mussadif Modak, working president of Kharghar Congress said, "Due to the presence of a dumping stop in the vicinity, the residents not only have to bear the foul stench but are facing health issues as

well. The garbage collected is in massive amounts which decomposes and causes air pollution. People are not able to stand outside due to the obnoxious stench. We want the PCMC officials to directly take the garbage to Taloja MIDC dumping yard rather than bring it to this dumping stop which is a double task for them as well."

Dr. Swapnil Pawar, Vice President of Congress in Panvel District said, "Many residents have complained about this issue. Moreover, having a dumping stop so close to any residential area is absurd as it can lead to serious health issues and can be breeding grounds for insects.
