In continuation of the Commission's letter of even number dated 28<sup>th</sup> August 2015 and your letter in response thereto, I am directed to state that, the Commission has decided to have a common schedule for the revision/preparation of electoral rolls for Karnataka North-West and Karnataka South Graduates' and Karnataka North-West and Karnataka West Teachers' Constituencies of Karnataka Legislative Council, Amaravati Division and Nashik Division Graduates' and Aurangabad Division, Konkan Division and Nagpur Division Teachers' constituencies of Maharashtra Legislative Council and Bareilly-Moradabad Division, Gorakhpur-Faizabad Division and Kanpur Division Graduates' and Allahabad-Jhansi Division and Kanpur Division Teachers' Constituencies of Uttar Pradesh Legislative Council.

Accordingly, the electoral rolls of the above-mentioned graduates' and Teachers' Constituencies shall be prepared with reference to 01.11.2015 as the qualifying date in accordance with the schedule below and following due procedure and guidelines as contained in the Commission's comprehensive instructions for electoral rolls for legislative councils issued vide its letter No. 37/LC/2013-ERS, dated 27<sup>th</sup> May 2013 and other subsequent instructions in the matter issued by the Commission from time to time:-
