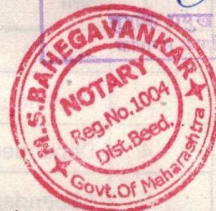

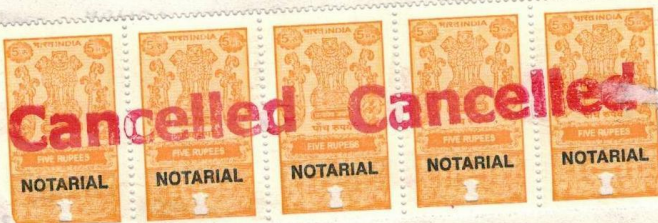

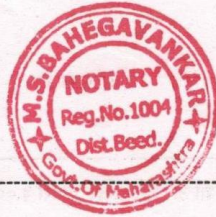

Note 5.—In pursuance of the Judgement dated 13th September 2013 of the Hon'ble Supreme Court in WP(C) No. 121 of 2008 Resurgence India V/s. Election Commission of India and other, regarding the filing of incomplete affidavit of candidates, the candidates are required to fill up all columns therein. No column can be left blank. At the time of filing affidavit, RO has to check whether all columns of the affidavits filed with the nomination paper are filled up. If not, the RO shall give a reminder to the candidate to furnish information against blank columns.
