*Note 5.*—In pursuance of the Judgement dated 13th September 2013 of the Hon'ble Supreme Court in WP(C) No. 121 of 2008 Resurgence India V/s. At the time of filing affidavit, RO has to check whether all columns of the affidavits filed with the nomination paper are filled up.
