1] The applicants /original accused nos.1 to 4 have filed this criminal revision petition under section 397 of Cr. P. C. against the order of issue of process dated 11/09/2018 passed by Ld. Addl. CJM, Pune in S.C.C. No 30238/2018.





2] The brief facts giving rise to this revision petition, are as under :

The respondent no.1 / original Complainant has filed the complaint under section 138 of Negotiable Instruments Act on 06/06/2018. Ld. Magistrate was pleased to take its cognizance and issued process against applicants for the alleged offence mentioned in S.C.C. No.30238/2018. On 24/08/2018 respondent no.1 i.e. original Complainant filed affidavit under section 145 of N. I. Act and on the same day Ld. Magistrate was pleased to issue process against accused. In the revision petition, the applicants have challenged that order of issue of process mainly on following two grounds.

3] Firstly when offence was committed applicant no.3 Mrs. Vajenmdala Poonam Rao was neither a director of the accused no.1 company or any ways connected with the said company. She already resigned from the post of directorship on 07/12/2015. She never met the respondent no.1 or any of its representatives at any point of time and has not signed any cheque and other documents on behalf of the said company. Thus, she has not played any active role in the functioning of accused no.1 company. The Complainant has not produced any material on record to prima facie show her any involvement in the impugned transaction. She has been falsely





implicated in the present complaint. Another objection is that before issuing order of process Ld. Magistrate has not recorded verification statement. He has overlooked the mandatory procedure laid down in section 200 of Cr. P. C. Complainant had only filed evidence affidavit under section 145 of the N. I. Act. Ld. Magistrate erred in believing that affidavit in issue of process. Ld. Magistrate ought to have observed that what was filed by the Complainant was an evidence affidavit under section 145 of N. I. Act and not verification statement or affidavit under section 200 of Cr. P. C. hence impugned order issuing process without first complying with mandatory provisions of Section 200 of Cr. P. C. was illegal and bad in law. Therefore, he prayed that the order passed by Ld. Magistrate in taking cognizance of the alleged offence and in mechanically issuing process against applicants, it liable to be set aside and hence that order be set aside.

4] In this context, he placed reliance on case of *Pooja Ravinder Devidasani Vs. State of Maharashtra and another* (2014) 16 Supreme Court Cases 1. That was a case under section Negotiable Instruments Act. Offence committed by the company. Question of vicarious liability as director on default of company arise but appellant director had resigned much before the issuance of the dishonoured cheques. His resignation was approved by the



Board of Directors. Formality of giving information to the Registrar of companies about his resignation was also fulfilled. In the entire complaint no role was attributed to her. She was non-executive director of the company. That cheque in question was issued by virtue of letter of guarantee cannot also be accepted in this proceeding. At the most letter of guarantee gave way for a case of civil liability. Hence, it was held that High Court erred in dismissing the petition that appeal under section 482 of Cr. P. C. for quashing complaint and it is a case of sheer abuse of process of law. Reliance is also placed on following cases :-

- i] Gunmala Sales Private Limited Vs. Anu Mehta and others (2015) 1 Supreme Court Cases 103,
- ii] K. K. Ahuja Vs. V. K. Vora and another (2009) 10 Supreme Court Cases 48 and,
- iii] Indian Bank Association and others Vs. Union of India (2014 ALL MR (Cri) 4178 (SC).

5] In light of these facts, following points arise for my determination. I have recorded my findings against them for the reasons recorded below.



### REASONS

#### Points No. 1 to 3 :-

6] Advocate for revision-petitioner in his argument stated that when the alleged offence was committed, applicant no.3 was neither director of accused no.1 company nor any way connected with the said company. She had already tendered her resignation of directorship on 07/12/2015 and it was accepted on 08/12/2015. She never participated in day to day management of the company. She had not signed any cheque or other document on behalf of said company having concern with this case. She has not played active role in the functioning of accused no.1 company.

Complainant prima facie failed to show any involvement of her in



the impugned transaction, therefore, order of issue of process passed against her be set aside. Secondly, before passing the impugned order, Ld. Magistrate did not record verification statement of the Complainant as required under section 200 of Cr. P. C. He only believed one affidavit in lieu of evidence filed under section 145 of N. I. Act. Therefore, impugned order of issue of process was passed without first applying the mandatory provisions of section 200 of Cr. P. C. Hence, it is bad in law and illegal. Therefore, interference is required in the impugned order at the hands of this court for setting aside for order.

7] Advocate for the respondent in his argument duly supported the order of Ld. Magistrate. It is his contention that said order is legal and proper. Instead of recording verification statement on the basis of affidavit filed by the Complainant, court can take cognizance and issued process. Therefore, he prayed that order of Ld. Magistrate is legal and proper. No case is made out for interference in that order. He placed reliance on following three case laws.

i] Lata Vs. Mode Export Pvt. Ltd., (2016 (4) Mh: L. J. 202,

In that case offence of dishonour of cheque under section 138 of N. I. Act was committed by the Company. Vicarious liability



of Director was there and hence Ld. Magistrate issued process. Petitioner sought to quash process issued against her on ground that on date when cheque in question was presented to bank and came to be dishonoured, she was no more director of company, as she had already resigned but when statutory demand notice was issued there was no such resignation presented on record nor it was acted upon. Moreover, on date of filing of complaint and issuance of process against her, fact of her alleged resignation was not at all acted upon as her resignation letter was ante dated. No unimpeachable or uncontrovertible evidence on record to show acceptance of petitioner's resignation by company on date on which it was alleged to be tendered. Therefore, it was held that the petitioner has failed to make out *prima facie* case for quashing of process issued against her. Petition dismissed.

ii] **S. M. S. Pharmaceuticals Ltd. Vs. Neeta Bhalla (2005 AIR (SC) 3512),**

In that case Hon'ble Supreme Court has laid down the requirement of complaint filed under section 138 of N. I. Act in a case in which offence was committed by the company. It was held that it is necessary to specifically aver in a complaint under section 141 that at the time the offence was committed, the accused was in charge of, and responsible for the conduct of business of the



company. This averment is an essential requirement of section 141 and has to be made in a complaint. Without this averment being made in a complaint, the requirements of section 141 cannot be said to be satisfied.

iii] **Rajesh Bhalchandra Chalke Vs. State of Maharashtra and another (2011 (1) AIR Bom R 322),**

In that case Complaint was filed against company and its director. The order of Ld. Magistrate was challenged in the writ petition. It was held that magistrate erred in taking cognizance without following procedure under section 200 of Cr. P. C. for non-examination of complainant on oath. It was held that whether in view of provisions of section 145 of N. I. Act, Magistrate, taking complaint under section 138 of N. I. Act along with documents in support thereof and verification in affidavit, still obliged to examine on oath, complainant and witnesses before issuing process. It was held that Magistrate can rely upon verification in form of affidavit filed by Complainant in support of his complaint.

8] In this case it is the case of Complainant that sometime in November 2015 an advance amount was given by Complainant company for purchasing Honda car for Cab/Taxi services. After constant follow-up for more than two years with accused, accused



company handed over two cheques bearing nos.742079 and 742078 both dated 08/03/2018 for Rs.20 lacs and 30 lacs respectively and those cheques was presented on 28/03/2018. They were returned by the Complainant's bank with endorsement "Exceeds arrangement". Thereafter, on 19/04/2018 statutory notice was issued. It was served on accused on 23/04/2018. Till 09/05/2018 amount of cheque was not paid (16<sup>th</sup> day from issuance of notice), therefore cause of action arose for filing the complaint. Thereafter, Complainant was filed complaint on 05/06/2018. In support of that complaint, Complainant has filed affidavit which is a replica of complaint.

9] Advocate for applicants pointed out that on 7<sup>th</sup> December, 2015 applicant no.3 tendered resignation from the post of directorship of accused company. Thereafter, on 08/12/2015 her resignation was accepted. She has filed certified copy of Form no.DIR-11 about notice of resignation of a director to the Registrar. In that form it has been mentioned that applicant no.3 Mrs. V. Rao has tendered her resignation on 07/12/2015 and with effect from 07/12/2015 she resigned from the post of directorship. He has also filed certified copy of Form DIR-12 giving particulars of appointment of Directors and the key managerial personnel and the changes among them. It is issued under the signature of Rupali



Modi, Company Secretary of the said company. In that form it has been specifically mentioned that on 08/12/2015 resignation issued by the applicant no.3 was accepted by the Board of Directors of the company. All these sequence of dates clearly show that before issuance of disputed two cheques applicant no.3 has already resigned from her post of directorship of accused no.1 company and that resignation even accepted by the Board of Directors of Company and its note was taken by Registrar of Companies in the relevant record.

10] This complaint is filed on 05/06/2018. Prior to that on 20<sup>th</sup> May, 2018 applicant no.3 Mrs. V. Rao issued notice reply through her advocate Mr. Vinay Vyas and informed that she has already resigned from the company and she is not authorized signatory. She has never signed any cheque for and on behalf of company. That notice reply was sent by RPAD. Its postal receipt is filed on record which shows that it was decided on 26/05/2018. Thus, before filing of this complaint that notice reply was received to the Complainant but Complainant did not delete her name as accused. After receipt of said notice reply it was his duty not to implead her as accused and clearly mention in his complaint that she gave notice reply and informed that she has resigned from the post of directorship but he failed to do so. Therefore, I d.



Magistrate issued process against her. Therefore, interference is required in the order of Ld. Magistrate as to issue of process dated 11/09/2018 against the applicant no.3.

11] As per ratio laid down in Rajesh Chalke case (Cited Supra) instead of recording separate verification of Complainant in case filed under section 138 of N. I. Act it is open to magistrate to rely upon the affidavit filed in support of complaint. Therefore, instead of wasting time for recording verification statement of Complainant, Ld. Magistrate has relied upon the affidavit filed by Complainant in support of complaint under section 138 of N. I. Act and passed order to issue process against accused.

12] As stated earlier except applicant no.3 that order of issue of process dated 11/09/2018 is perfectly legal and proper against applicant no.1 company and applicant nos.2 and 4. No case is made out for any interference in that order against them. In light of these factual and legal position, I answer above said points accordingly and hold that only to the extent of process issued against applicant no.3 Mrs. Vajendla Poonam Ramananand Rao, the order of Ld. Magistrate is liable to be set aside. Hence, I pass the following order.


- 1] The Criminal Revision is partly allowed.




