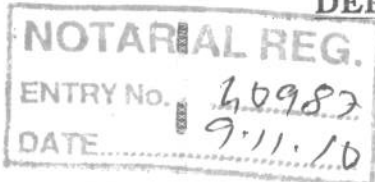

- ii) The deponent has obtained a loan of Rs. 1,77,980/- from Nagpur Zilla Shala Karmachari Credit Co-op. Society Ltd. Nagpur and paying instalment of Rs. 3,300/- per month for the repayment of the said loan.
- iii) The deponent has got bank account No. 331 at Nagpur District Central Co-op. Bank Ltd. Nagpur and has got overdraft facility of Rs. 78,000/- and presently Rs. 17,186/- is balance to the credit of the deponent.
- iv) The deponent has got the LIC policy of Rs. 2,00,000/- having monthly premium of Rs. 1,000/- and another LIC policy of Rs. 1,00,000/- and paying Rs. 584/- towards monthly premium of the said policy.
- v) The deponent's wife Mrs. Drovinee Devaji Bhujade has got LIC policy of Rs. 2,00,000/- and paying Rs. 12,000/- per year towards the said premium. Similarly the wife of the deponent has got gold weighing 10 Tolas.

- vi) The deponent do not own and possess any agriculture land or plot of land in his name or in the name of his wife or any dependant children. However there is ancestral agriculture land admeasuring 52 Acres (19.53 H.R.) which is in cultivating possession of the father of the deponent the said land have Kh.Nos. 90, 91 (2.68 H.R.), 66, 68 (5.59 H.R.) at Mouza - Mohadara, Tah. Kuhi, Dist. Nagpur another land having Kh.No. 102, 149/1, 150/1, 149/2, 150/2 (11.26 H.R.) situated at Mouza - Salai, Tah. Umrer, Dist. Nagpur. All these lands are agriculture lands and none of these lands are transferred in the name of deponent till today. The approximate value of the abovesaid land is between 2.5 to 2.75 Crores.
- vii) The deponent has entered into an agreement to purchase a plot at Suryanagar, Mahalaxminagar, Nagpur but the sale deed of the same is yet not executed in the name of deponent and hence he could not get the title over the said plot of land.

Therefore the deponent has got the only abovesaid assets and properties in his name and in the name of his wife however there is no any other property in the name of deponent, his wife or in the name of his dependents.

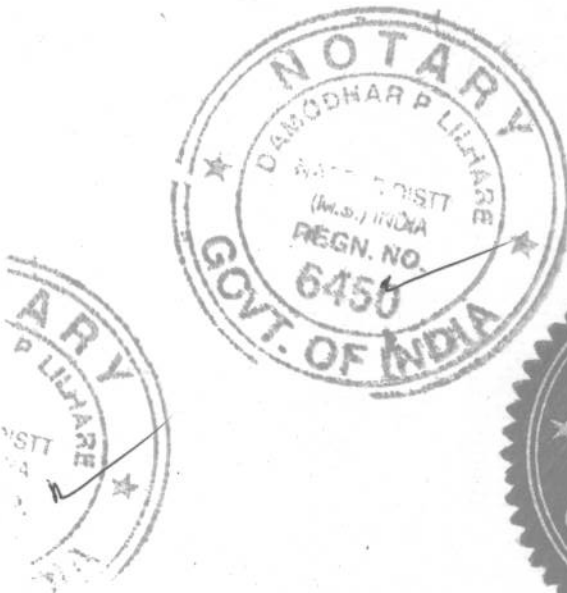
